Seaside Run

The final race saw our largest field to date with 219 runners. The race confirmed our view that 300 is the maximum we can accommodate. We had a total 552 Runners over the series of which 336 were men and 216 women resulting in an average of 179 runners per race We have been surprised by the number of NEW Seasiders e.g. Last Race 84, over a third of the field, were first-timers. The Awards evening was a great success with approximately 50 people attending. The awards were presented by Roy. Grand Prix Awards – 29 for 6 races 29 for 5 races and 22 category prizes were awarded. The policy of no Under 11 next year was announced.
